On behalf of the Ministry of Knowledge Economy of the Republic of Korea, I welcome you to the Korea Investment Forum at the Savoy Hotel, London on the 1<sup>st</sup> of December.

As the Republic of Korea is one of the UK's largest trading partners in Asia and the fact that the UK is the 4th largest investor in Korea after US, Japan and Holland, the economic and business relations between Korea and UK are growing rapidly. Last year alone, Korean companies invested US\$ 3.2billion in the UK, which clearly demonstrates the very close business ties between the two countries.
